

PARENTS / GUARDIANS' DECLARATION AND CONTRACT OF ENROLMENT

POLICIES

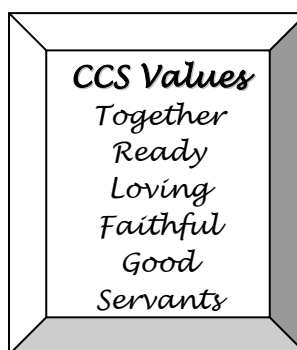
1. I/We, the legal guardian(s) of _____ (learner name) accept the terms and conditions of the constitution and the supporting policy documents of the school, issued by the council of the school, to which I / we have had reasonable access.
2. I/We agree to abide by these policies (with special reference to the School Fee Policy, the Code of Conduct of the School and any other policies or procedures that may be adopted from time to time by the School.
3. I/We hereby undertake to abide by and comply with all the rules and regulations of the School, and I/we hereby acknowledge that it is incumbent upon me/us to make myself/ourselves familiar with all the rules pertaining to the School.
4. I/We acknowledge that I/we am/are responsible for my/our child/children whether on the property of Centurion Christian School or not, after the published finishing times of any school activity/event/function.
5. I/We will ensure that _____ (learner name) abides by all policies applicable to him/her.
6. I/We understand that the School reserves its right to give a shorter period of notice of termination of the enrolment contract should the Principal determine a shorter notice period as being appropriate.

MINISTRY OF THE SCHOOL

7. I understand that the educational programme is an integral part of the body of Christ ministry, which I am expected to support.
8. I agree to uphold and support the high academic standard of the School by providing a place at home for my child to study and by encouraging my child in the completion of any homework or assignments.
9. I appreciate the Code of Conduct of the educational ministry and will not tolerate profanity, obscenity in word or action, any behaviour unbecoming a Christian and contrary to the Word of God, dishonour to the Godhead or the Word of God, or disrespect to the staff of the School.

DISCIPLINE

10. I agree with and support the Code of Conduct and Character Guidance Route of the School.
11. I hereby agree to support School regulations on the applicant's behalf and authorize the School to administer discipline as it deems wise and expedient for the training of my child.
12. I understand that the School reserves the right, after parental conference, to dismiss any child who fails to comply with the established regulations and discipline or whose parents do not assume their responsibilities to the educational ministry. I accept that the School Administrator / Principal / Pastor can at any time request that a pupil be removed from the School if the situation requires such action. Full fees and other amounts payable in respect of such a pupil will remain due to the School except to any extent decided by the Council.



PARENT INVOLVEMENT

- 13. I commit myself as an **active parent** to be involved in the activities of the School with my profession and with my God-given talents.
- 14. I undertake to attend the PTF each term as well as the annual AGM.
- 15. I/We commit to attend the Parent Orientation Day for new parents to be able to support my child fully and effectively.

GENERAL

- 16. If the School decides to terminate the enrolment of a learner, then it may do so by giving a full calendar month’s notice at which the parent shall be required to withdraw the learner.
- 17. I/We confirm that all the particulars that I/we may furnish or that have been furnished on this form shall, to the best of my/our knowledge and belief, be full, true and accurate.
- 18. I/We undertake to advise the School in writing of any changes to the details included herein.
- 19. I/We choose the residential address completed on the application form as my/our *domicilium citandi et executandi* for the service on me/us by the School of all notices, processes, and other communications.

CCS COMMITMENT

- 20. Unless you expressly notify us in writing to the contrary, you consent to the Student participating, under proper supervision, both in and outside the School, in sports and other activities (including contact sports) which may entail some risk of physical injury, as well to the Student travelling to, and participating in, School activities and programmes outside the School. Subject to the School taking reasonable care to avoid harm, and save for any gross negligence on the part of the School, its employees or agents, the School is not responsible for any loss or damage, of whatever kind, resulting from such sports, activities or programmes and you indemnify the School against any claims in that regard.

DISCLAIMER

- 21. The School does not take any responsibility for any theft or loss of, or damage or destruction to any property of whatever nature (including school clothing, sporting equipment, books, or any other personal possessions) brought onto the School premises by my/our child.
