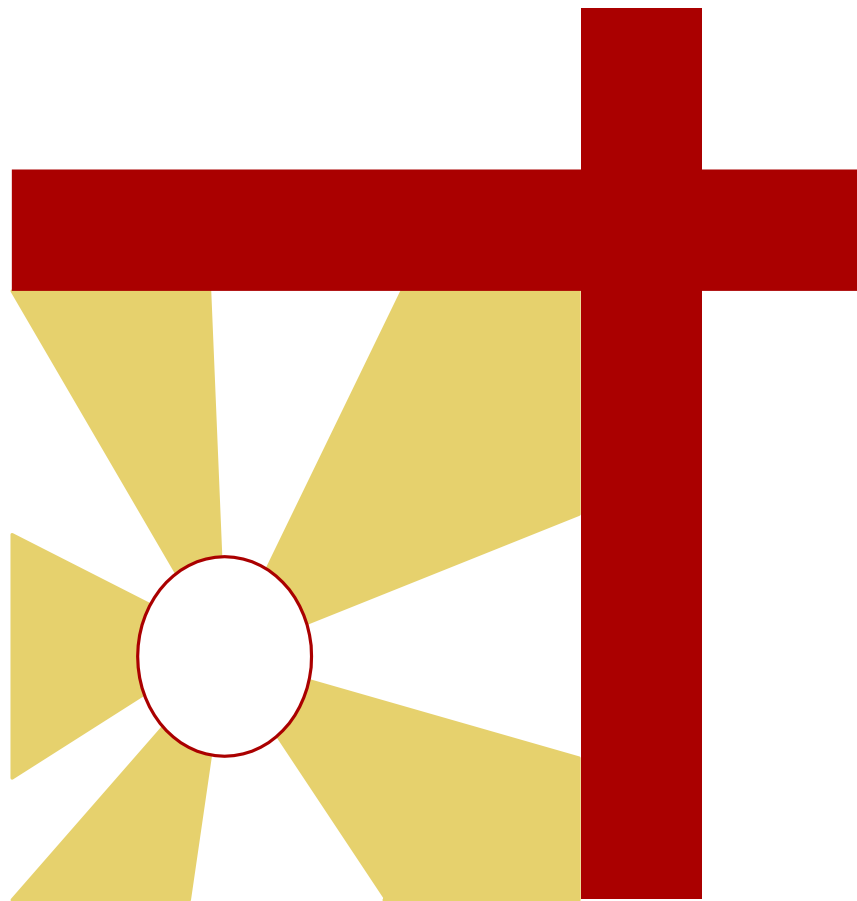

Statement of Faith of Centurion Christian School

In line with the Constitutional right to follow our own distinctive faith: Centurion Christian School hereby declares its Statement of Faith. The purpose and sole object of this School is to provide a Christian philosophy of education for primary and high school students. We believe that education cannot take place in a moral vacuum and will consequently have a strong Christian foundation and ethos. We try to challenge each student intellectually, to stimulate their intellectual growth, and to develop in them a thirst and passion for the Word of God. Please read the Statement of Faith closely to determine if it is in accordance with your family's personal beliefs and values.

Our teaching is fundamentally Protestant in nature, based on the Bible and in accordance to the teachings of the Reformatist church fathers and their writings. The School subscribes to the following basis of faith to which all members, parents of learners, employees and office bearers must subscribe without reservation. Children may only be accepted into the school if the parents/guardians are able in good conscience to sign the Statement of Faith and declare their unconditional agreement with the Statement of Faith of this Constitution.

We strive to create an environment in which the school partners with parents and church to provide excellence in education in order to prepare children for life.

We believe in:

- The divine inspiration of the Bible equally in all parts and without error in its origin. (2 Tim. 3:16; 2 Peter 1:20-21);
- One God (eternally existent Father, Son and Holy Spirit) Who created man by a direct immediate act (Gen. 1:1; Matt. 28:19; John 10:30; Gen. 1:27);
- The pre-existence (John 1:1), incarnation (John 1:14), virgin birth (Isa. 7:14; Matt. 1:23), sinless life (Heb. 4:15), miracles (John 2:11), substitutionary death (1 Cor. 15:3; Eph. 1:7), bodily resurrection (John 11:25; 1 Cor. 15:4), ascension to Heaven (Mark 16:19), and the second coming of the Lord Jesus Christ (Acts 1:11; Rev. 19:11);
- The fall of man, the need of regeneration through the Holy Spirit on the basis of grace alone, and the resurrection of all to eternal life or damnation (John 3:16-19, 5:24-25; Rom. 3:23, 5:1, 8-9; Eph. 1:3-5, 2:1,8-10; Titus 3:5; John 5:28-29);
- The spiritual relationship of all believers in the Lord Jesus Christ, living a life of righteous works, separated from the world, and witnessing to His saving through the ministry of the Holy Spirit (Rom. 8:9; 1 Cor. 2:12-13; Gal. 3:26-28); Rom 8:13-14; 1 Cor. 3:16, 6:19-20; Eph. 4:30, 5:18).
- With regards to sexual behaviour, in heterosexual relationships between a natural man and a natural woman within the confines of lawful matrimony (Gen. 2:18-25; 1 Cor. 7:2-5; Heb. 13:4).
- We believe that God wonderfully and immutably creates each person as either biological male or biological female, and that these two distinct, complementary sexes together reflect the image and nature of God. (Gen 1: 26-27). We believe that any form of sexual immorality is sinful and offensive to God. (Matt. 15:18-20; 1 Cor. 6:9-10)

We seek inclusion rather than separation and therefore expect learners not to categorise, label or physically identify themselves with any cultural affiliation, ethnic grouping or traditional belief system through the wearing of cultural, ancestral, political, traditional or superstitious jewellery, clothing, symbols or markings. Such items are also not part of the CCS school uniform standards and regulations.

We adhere to the Protestant orientation of Sunday as the day set aside for corporate or private worship and we strive not to arrange sports events, meetings, training etc. on Sundays. All other days of the week may be used, without reservation, for sports events, meetings, training, cultural events, compulsory parent-teacher interactions etc.
